# 2025 ROSEMARY BEACH HOLIDAY TOUR OF HOMES

## SPONSOR GUIDELINES

### CUP OF CHEER SPONSOR:

- Sponsor will set up a “Hospitality Area” in a designated area in North Barrett Square.
- Any collateral distributed must be relevant to the products or services that are provided by the sponsor.

### HOLIDAY SPIRITS SPONSOR:

- The sponsor agrees to furnish and serve spirits (beverages) for a minimum of 700 attendees and any vendor products as well as providing a company representative to be present for the duration for the event.

### FEATURED HOME SPONSOR:

*Homes will be assigned on a first come, first serve basis.*

- Any collateral distributed must be relevant to the products or services that are provided by the sponsor. They may not include products offered by other entities not listed as a sponsor.
- Sponsor will share the home with the Home Décor Sponsor and will be designated an area within the home to distribute collateral and/or promotional items.
- Each Sponsor will provide a representative to answer question regarding their product as well as manage any promotional items being distributed. Sponsor will provide the point of contact information by no later than November 25, 2025.
- The sponsor agrees to furnish and serve amenities for a minimum of 600 attendees (i.e. beverages, snacks, etc.) and any vendor products as well as providing a company representative to be present for the duration for the event.
- Each sponsor will refrain from offering any items, food beverage or otherwise, that could cause staining or damage to the property.

**HOME DECOR SPONSOR: *Homes will be assigned on a first come, first serve basis.***

- Each Home Décor Sponsor will receive a \$750 cash stipend to be used on materials in the home.
- Each sponsor will provide a raffle item (valued at \$200). Raffle items must be turned in by November 17th. If using an item that will be displayed in the home, please provide a photo and description of that item by November 15th.
- Sponsor will have access to the home for decorating at least 3 days prior to the event.
- Home selections will be finalized on November 1, 2025. At that time, a tour can be scheduled for planning purposes based on availability.
- Sponsor will provide decorations for the following: interior and exterior entryway and at least three rooms in the home as well as a tree of some nature.
- Sponsor are encouraged to decorate more than the requirement.
- Sponsor may not use any materials that may cause damage or staining to the home. Additionally, any items affixed to furniture or walls must be temporary (no nails, staples or heavy adhesives.)
- Upon event completion, Sponsor will have until 6:00 pm on Sunday, December 8th to return the home to its original condition.
- During the tour, each sponsor will provide a representative to answer questions regarding their product or service. Sponsor will provide the point of contact information by no later than November 15, 2025.
- Any collateral provided must be relevant to the products or services that are provided by the sponsor.
- Sponsor may sell the items used to decorate the home provided that the items remain on display in the home for the duration of the tour. Sponsor will refrain from selling non-holiday related décor.
